

## 2020 Orvis #NewSeason Giveaway

**How to Enter:** The Sweepstakes begins at 12:00:00 p.m. Eastern Daylight Time (“EDT”) on 3/18/20 and ends at 11:59:00 p.m. Eastern Daylight Time (“EDT”) 4/2/20 (“Promotion Period”). To enter, during the Promotional Period, you must (i) have a registered account for the Facebook application (“Facebook”) or the Instagram application (“Instagram”); and (ii) upload/post at least one original photo to facebook.com/orvisflyfishing (1) or instagram.com on the theme of “fly fishing” as announced on the Orvis News website <https://news.orvis.com/flyfishing/>, with the hashtag “#NewSeasonRecon” (collectively, an “Entry”).

Entries must be created solely by each entrant. Furthermore, entries must comply with Facebook's and Instagram's terms of use and these Official Rules. If you do not already have a Facebook or Instagram account, you may register for an account; it is free to join. An Entry that does not include all required information and adhere to the foregoing and following requirements will be considered void and will not be considered in the judging of this contest.
