

2020 Shooting Grounds #MyOrvisLife Giveaway

How to Enter: The Sweepstakes begins at 12:00:00 p.m. Eastern Daylight Time (“EDT”) on 5/1/20 and ends at 11:59:00 p.m. Eastern Daylight Time (“EDT”) 5/31/20 (“Promotion Period”). To enter, during the Promotional Period, you must (i) have a registered account for the Facebook application (“Facebook”) or the Instagram application (“Instagram”); and (ii) upload/post at least one original photo to facebook.com/orvishillcountry, facebook.com/orvissandanona, facebook.com/orvisatpursellfarms or instagram.com with the hashtag “#MyOrvisLife” (collectively, an “Entry”).

Entries must be created solely by each entrant. Furthermore, entries must comply with Facebook's and Instagram's terms of use and these Official Rules.
